Rental: Esther Fortney indicated that we have 39 rental agreements on file, 2 vacancies and 2 without agreements. Adoption of the revised rental agreement is being postponed because of changes taking place in State law governing private communities. Social: Helen Ann Skowyra presented a detailed report of the year's activities. Pool: Sid Johnston reported on the ups and downs of the pool this year and thanked the volunteers for their efforts in opening and closing the pool, helping to minimize staff pool time. Water: Ed Skowyra presented a summary of completed and pending projects for the water system.
- 5. <u>Manager's Report</u>: Gerry Taylor presented his report summarizing activities to computerize our Club's record's, accounting and work flow data. The Club was involved in two lawsuits during the year and has had to commit a significant level of staff time to assist in case preparation.
